Quality and Regulatory Affairs Update

- CMS Approved AQI NACOR to support four additional Improvement Activities.
 - IA_PM_14: Implementation of methodologies for improvements in longitudinal care management for high-risk patients
 - IA_PM_18: Provide Clinical-Community Linkages
 - IA_ERP_1: Participation on Disaster Medical Assistance Team, registered for 6 months.
 - **IA_ERP_2:** Participation in a 60-day or greater effort to support domestic or international humanitarian needs.

Quality and Regulatory Affairs Update

- CMS letter recognizing anesthesiologists and their COVID-19 Response.
- CMS is allowing the "expansion" of the attestation and suggested documentation requirements for certain existing IAs.
 - <u>For example</u>: If your practice has implemented COVID-19 policies and procedures for donning and doffing PPE/held in-services for proper donning and doffing. Consider attesting to IA_CC_8: Implementation of documentation for practice/process improvements



 - This includes participants for NACOR Basic, Benchmarking, and Quality Reporting








- Updating your list makes your practice reports easier to understand, clears up clutter and assists with the reconciliation billing process that will occur after the new year
 - Provider names are not submitted in the data so the names must be entered manually
- Provider Status
 - Active
 - Inactive Providers that are on a temporary leave and will be coming back to the practice
 - Remove- Providers that have retired or are no longer with the practice


Facility List Audit


