AQI

- You can *opt-in* to MIPS if you are an eligible clinician or group who exceeds 1 or 2 (but not all 3) of the low-volume threshold criteria during either review period. If you are an eligible clinician or group who opts-in to MIPS, you will receive a MIPS final score and a payment adjustment in 2021.
- You can voluntarily report if you are a clinician or group that is not MIPS eligible. If you report voluntarily, you will receive a MIPS final score but no payment adjustment.






- What do we mean by "elective" procedures?
 - AQI defines elective as "A surgical, therapeutic, or diagnostic procedure that can be performed at any time or date with an agreement between the surgeon and the patient"
 - These cases are distinct from urgent or emergent
- What if I have a denominator-eligible case that doesn't require multimodal analgesia because pain is well-controlled with a single mode of analgesia?
 - Because we have to rely on ASA billing codes, we can't have a perfectly precise denominator
 - We do <u>not</u> recommend giving additional medications that are not indicated just for the sake of meeting the measure
 - There is not an expectation of 100% performance, it only matters how you perform compared to your peers





- Does the denominator include depolarizing or non-depolarizing medications?
 - There was a typo in early versions of the QCDR measure book. These measures are meant to include non-depolarizing medications
 - A corrected version of the book has been posted on the <u>AQI website</u>
 - The most current version of the book is dated February 4th (version 2.1)

Internal Improvement Measures – 2019 Update

- Updated Internal Improvement Measures COMING SOON
- These are additional, optional measures for reporting for tracking quality metrics not used for MIPS or sent to CMS
- New additions include:
 - Post-Anesthetic Transfer of Care Measure: Procedure Room to a Post Anesthesia Care Unit (PACU)
 - Post-Anesthetic Transfer of Care: Use of Checklist or Protocol for Direct Transfer of Care from Procedure Room to Intensive Care Unit (ICU)
 - New Corneal Injury Not Diagnosed Prior to Discharge
 - Geriatric Cognitive Assessment
 - Lung-Protective Ventilation during General Anesthesia
 - Ambulatory-specific measures NEW!

2018 MIPS Data Submission

AQI is in the process of completing the data validation process and will begin submitting 2018 MIPS quality data to CMS the last week in March.

- 2018 Submission
 - 355 practices
 - 15,305 providers

Final MIPS scores will be available in July. Eligible Clinicians and Group Practices will need to have an EIDM account with CMS to view results.

EIDM accounts can be obtained through the CMS enterprise portal. Click New User Application then select "PQRS: Physician Quality Reporting System" when asked to "Choose your application




2019 NACOR Reporting Registration

- Quality Concierge Practices do not need to register!



2019 XML Schema Changes



- April 15th XML Schema updates to be released
 - Only minimal changes adding optional variables, adding to existing enumerations
 - Changing AQIXMLVersion number from
 - 2018V1.0 -> 2019V1.0
 - 2018V1.0R -> 2019V1.0R
- July 1st Files will be required to use new format.
 - Most vendors will only need to change version number.

Data Warehouse Transition




- Beginning in July 2019, AQI will partner with ePreop's analytics and registry software to become NACOR's data warehouse. What does this mean for your practice?
 - No changes to the data upload process: Files will continue to be uploaded to https://nacor.ePreop.com
 - No changes to the data validation email: Data submitters will continue to receive data validation email as normal
 - Clinicians and practices enrolled in 2018 MIPS reporting and NACOR Basic services will continue to access NACOR dashboard reports through ArborMetrix through the end of June
 - Clinicians and practices that enroll in 2019 MIPS reporting and NACOR Basic will gain access to a new dashboard provided by ePreop currently in development




AQI NACOR Data Flow Chart
