2021 ASA Membership Renewal Deadline


- For clinicians to receive ASA Member pricing for 2021 NACOR reporting, clinicians must have an active 2021 ASA membership.
- Final payment for AQI services is determined by 2021 ASA membership status. Physicians who do not renew will be charged the NACOR non-member rates.
- Deadline to renew membership is Friday, October 1, 2021.
  <u>2021 ASA Memberships must be paid by October 22,</u> <u>2021</u>.

#### **2021 NACOR Reporting Registration Deadline**

- Deadline to register is Friday, October 1st, 2021
- A registration form is required for practices registering for Basic, Benchmarking and Quality.
- Quality Concierge practices <u>do not</u> need to register.

### **Data File Email Reminders**



- AQI will begin sending email notification reminders to AQI champions in October
- Reminders will be sent every other week until the final deadline (2/14/22)
- Notifies AQI champions:
  - If no data files have been submitted to NACOR for the 2021 reporting year
  - If a new data file has been uploaded

If a new file has been uploaded review the NACOR dashboard prior to deadlines so you have an opportunity to review any errors and correct them before the final deadlines.

## **Improvement Activities Category**

March Improvement Activities component is still 15% of the total MIPS score

ECs/groups must complete activities worth 40 points

High Weighted Activities worth **20 points** Medium Weighted Activities worth **10 points** 

For groups to attest to an activity at least 50% of the clinicians (in the group) must perform the same activity during any continuous 90-day period, or as specified in the activity description, within the same performance period

Special reweighting for the following providers: Small, rural, HPSA and non-patient-facing ECs/groups

High Weighted Activities worth **40 points** Medium Weighted Activities worth **20 points**


# **Top 5 Improvement Activities (IA) Reported in 2020**

The *last* consecutive 90-day period to report an Improvement Activity begins October 1 and ends December 31.


IA Number	IA Name
IA_EPA_1	Provide 24/7 access to eligible clinicians or groups who have real-time access to patient's medical record.
IA_BE_13	Regularly assess the patient experience of care through surveys, advisory councils and/or other mechanisms
IA_PSPA_7	Use of QCDR data for ongoing practice assessment and improvements
IA_BE_6	Collection and follow-up on patient experience and satisfaction data on beneficiary engagement
IA_AHE_6	Provide education opportunities for new clinicians

# **FTP Access**





- All FTP accounts are disabled if no activity occurs within a 90-day window.
- If your practice is ready to upload data and it has been >90 days since a file has been uploaded submit a help desk ticket to <u>nacorsupport@asahq.org</u> for your account to be enabled.
- The FTP account has no impact on user access for the NACOR dashboard



## **Individual Reporting Consents**

- For practices reporting as individuals AQI is now collecting provider consents.
- Consents with missing fields will not be processed and will be sent back to the practice for corrections

THIS FORM IS NOT APPLICABLE IF PARTICIPANT HAS ELECTED TO REPORT AS A GROUP.

The undersigned clinician ("EC") represents and warrants that s/he:


- b) voluntarily consents to the terms of the Addendum, including the submission of data on behalf of the EC by The Anesthesia Quality Institute ("AQI") to the Centers for Medicare and Medicaid Services ("CMS") in accordance with the quality reporting option selected by the Group/Facility, which has been disclosed by the Group/Facility to the EC;
- c) has authorized the Group/Facility to consent on his/her behalf and bind him/her to the terms stated in the Addendum, including, but not limited to, the waiver and release in Section 13 of the Addendum;
