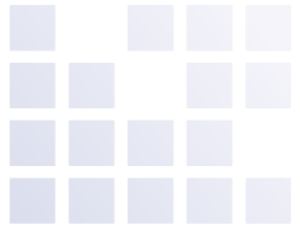

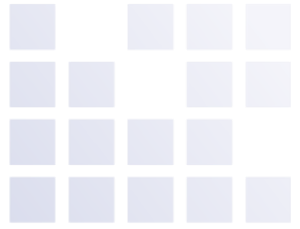

2019 Deadline Reminders- ASA Membership and Quality Reporting

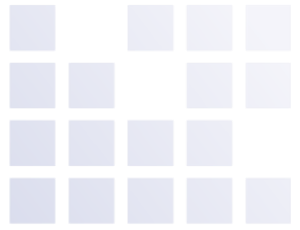


- ASA Membership Deadline **October 1, 2019**
 - Please make sure your members renew their ASA membership prior to the above deadline or they will be charged the NACOR non-member fee for 2019
 - This includes participants for NACOR Basic and NACOR Quality Reporting
- AQI NACOR Registration Deadline – **October 31, 2019**
 - All practices, new and renewals, need to complete a [2019 order form](#)
 - CMS is requiring 12 months of quality data for 2019 quality reporting year, so registering ahead of schedule can assist your practice in a successful quality reporting year!
- When completing your order form, if your practice ID has three digits (Example: PID 098), then add a “0” to the beginning of your practice ID. The form requires 4 digits in the practice ID field.



CMS Audits

- The Centers for Medicare & Medicaid Services (CMS) has contracted with Guidehouse to conduct data validation and audits of a select number of Merit-based Incentive Payment System (MIPS) eligible clinicians. MIPS eligible clinicians and groups are required by regulation to comply with data sharing requests, providing all data as requested by CMS.
- If selected for data validation and/or audit:
 - you will receive a request for information from Guidehouse sent via email or by certified mail.
 - You have **45 days from the date of the notice** to provide the requested information.
 - If your practice receives a request and wants AQI to assist with data submission, email AskAQI@asahq.org as soon as possible.
- If your practice does not provide the requested information, CMS may take further action, including the possibility that you will be selected for future audits.



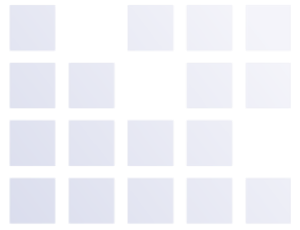

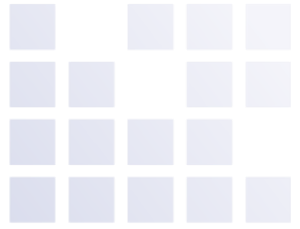
